HLF Prosper with Dragon Savings and Fixed Deposit Promotion

HONG LEONG FINANCE LIMITED ("HLF") – TERMS AND CONDITIONS GOVERNING **Prosper with Dragon Savings and Fixed Deposit Promotion ("Promotion")**

- 1. Definitions
 - Unless otherwise defined in the Terms and Conditions, the following words and phrases shall have the meaning hereby assigned to them:
- 1.1 "Account" means Fixed Deposit and Savings Account with HLF.
- 1.2 "Accountholder" means (i) an individual(s) who is/are an existing holder(s) of Fixed Deposit or Savings Account or (ii) an individual(s) who successfully opens/open a Fixed Deposit or Savings Account as a holder(s) of the account.
- 1.3 "Fixed Deposit" means Silver 40 Plus, Golden 55 Plus and Fixed Deposit.
- 1.4 "Savings Account" means Premium SAVER, Fixed Savings Account and Savings Account.
- 1.5 **"Fresh Funds"** mean funds that are not transferred from any existing Savings Account and Fixed Deposit; and not withdrawn from any existing Savings Account and Fixed Deposit and redeposited (whether part or all the amounts withdrawn) into a Savings Account or Fixed Deposit.
- 1.6 "Reward" means reward for this Promotion including "Ang Pow Reward" ascribed to it in Clause 4.2 and "Cash Reward" ascribed to it in Clause 5.2.
- 1.7 **"New Customer"** means an individual that has no deposit balance with HLF in the six months preceding the commencement of the Promotion Period

- 3. Savings and Fixed Deposit Lucky Draw ("Lucky Draw")
